### **President:**

Opening Statement: On the behalf of the request from Concern Neighbor we are here to discuss the request from Concern Neighbors to dissolve the Corporation and HOA. This meeting will be kept orderly and civil. Those who signed up to speak have three (3) non-transferable minutes to speak. Sabrina Sharpe is videoing the meeting on behalf of the Concern Neighbors. A letter from an Owner Gerry Cusack was read. He stated that property values will decrease if there is no HOA.
